# Trustee Report and Accounts for the period ended 31st March 2023

#### **Governance and Trustees**

The Helmsley Recreational Charity (The charity) is an amalgamation of two charities, Helmsley Recreation Ground and the John Atkinson Memorial Playing Field, under a scheme produced by the Charity Commission in December 2006. Helmsley Town Council is the Sole Trustee of Helmsley Recreational Charity.

## Charitable Objectives as set out in the governing document are:

- 1. In the interests of social welfare, to improve the conditions of life of the beneficiaries without distinction of political, religious or other opinions by the provision and maintenance of a recreation ground, and
- 2. In the interests of social welfare, to improve the conditions of life of the beneficiaries without distinction of political, religious or other opinions by the provision and maintenance of facilities for recreation and other leisure time occupation.

### Report 2022-2023

The report covers 12 months to the 31st March 2023. The Charity has, with the exception of the Car Park, leased the pool to two Charitable Incorporated Organisations - Helmsley Open Air Swimming Pool and Helmsley Sports Club - the Pavilion, the tennis courts, the bowling green and pavilion together with the John Atkinson Memorial Playing Field. Both CIOs contribute towards the maintenance of the car park via a sinking fund. Each agreed to contribute £250pa for five years starting in 2020.

#### Grants

The Charity does not usually award any grants though it may under the terms of the Governing Document.

## Details of any funds materially in deficit

No funds were materially in deficit. A VAT claim will be made following the internal audit.

# Policy of the Charity in respect of reserves

Two working groups were set up to plan for the financial future of the Charity, one with representatives of Helmsley Sports Club, the other with representatives of the Pool. Neither has met.
